

# Drug Sheet Transition to ASHP

## Frequently Asked Questions

WebMD Ignite is excited to announce that we are partnering with the American Society of Health System Pharmacists (ASHP) to provide improved drug sheets/ monographs to our customers. ASHP will be replacing the current vendor, which is FDB.

### Who is the ASHP?

The American Society of Health System Pharmacists (ASHP) is a leading provider of evidence-based drug monographs, currently trusted by the National Library of Medicine and the FDA. Recognized as the standard for patient drug information, ASHP Patient Medication Information (PMI) is the first private sector publication developed for educating consumers and patients about their drugs; first published in 1978.

### Why did WebMD Ignite select ASHP as their preferred vendor for medication sheets?

This partnership expands our coverage of drug sheets/monographs for our clients as we continue to strive for providing the best content coverage in the industry.

In addition, ASHP PMI database conforms to the U.S. Department of Health and Human Services Keystone Guidelines for the provision of "useful" prescription medicine information to consumers and the FDA's Guidance for Useful Written Consumer Medication Information.

### What information will be included in the new medication sheets?

The monographs include the title, introductory information, brands, common brand names, uses, how to use, special precautions, special dietary instructions, side effects and storage and disposal. Click here to view a [sample drug sheet/monograph](#).

### What is the timeline for transitioning to ASHP?

The timeline for transition is dependent on whether you access your content via an online or offline product.

**Online clients** refers to clients who utilize Krames/WebMD Ignite Content via Krames On-Demand (including KOD Exporter), Krames on FHIR, and API (whether it is via SMART on FHIR or pulled from the v2 or v3 API). Online clients will receive the new information as soon as it is in production. For customers accessing our services via online capabilities, **the transition will automatically occur on June 4, 2024.**

**Offline clients** refers to clients who ingest Krames/WebMD Ignite Content into their EMR by pulling it from an FTP site and then importing that content separately into their EMR so that it's stored locally, not dynamically. For customers who take an import, **the transition will take place as part of the Summer content update scheduled for August 26, 2024.**

### What should I do to prepare for the transition if I'm not an online client?

- **Epic:** Import the package with new content as usual. You will need to hide the old drug sheets. To do so, please reach out to your Epic TS and refer to the Sherlock ticket 5594485 and request that they hide content with the prefix "208".
- **Meditech:** For clients using the FTP site, the FTP packages with new drug sheets will include deactivated old drug sheets. The old content will be automatically archived upon import. For those clients who use KOD Exporter, you will need to download from the Krames FTP the package with the deactivated old drug sheets AND the deactivated package separately. Combine with the downloaded quarterly update package and then import them. The old drug sheets will be automatically archived.
- **Cerner:** No action needed. The medication sheets will be provided to Cerner and reflected accordingly.



- **Krames on Demand (KOD):** You will need to download the package with the deactivated old drug sheets from the Krames FTP site. Combine your downloaded quarterly update package with the deactivated drug sheet package and then import them. The old drug sheets will be automatically archived.

### **Is there a crosswalk of the new title list compared to the FDB titles?**

### **What will happen if we don't replace the FDB drug sheets?**

All online clients will get the new content automatically on June 4, 2024. For customers taking an import via FTP, the transition will take place as part of the Summer content update scheduled for August 26, 2024.

It is important that the August content package be taken immediately. If clients do not transition to the new drug sheets, their content will not be updated and over time will become outdated.
